

CALL FOR EXPRESSION OF INTEREST (EOI)

PRE-QUALIFICATIONS OF SUPPLIERS FOR GOODS AND SERVICES 2023-2025

INTRODUCTION

The Sri Lanka Medical Council (SLMC) is in the process of updating it's register of local suppliers for Goods and Services. SLMC will assess the Expressions of Interest (EOI) submitted by the vendors to register them as SLMC prequalified suppliers. The pre-qualifications of suppliers will help to establish a robust supplier database and conduct due diligence on the suppliers.

SLMC requests you to submit the EOIs in the attached templates which are in the SLMC website (www.slmc.gov.lk).

- a. it is not bankrupt or being wound up, having its affairs administered by the courts, has not entered into an arrangement with creditors, has not suspended business activities, is not the subject of proceedings concerning the foregoing matters, and is not in any analogous situation arising from a similar procedure provided for in national legislation or regulations.
- b. it is solvent and, in a position, to continue doing business for the period stipulated in the contract after the contract signature, if awarded a contract by SLMC;
- it or persons having powers of representation, decision making or control over the Company have not been convicted of an offense concerning their professional conduct by a final judgment;
- d. it or persons having powers of representation, decision making or control over the Company have not been the subject of a final judgment or of a final administrative decision for fraud, corruption, involvement in a criminal organization, money laundering, terrorist-related offences, child labour, human trafficking or any other illegal activity.
- e. it is in compliance with all its obligations relating to the payment of social security contributions and the payment of taxes in accordance with the national legislation or regulations of the country in which the Company is established.
- f. it is not subject to an administrative penalty for misrepresenting any information required as a condition of participation in a procurement procedure or failing to supply such information.
- g. it has declared to SLMC any circumstances that could give rise to a conflict of interest or potential conflict of interest in relation to the current procurement action.
- h. it has not granted and will not grant, has not sought and will not seek, has not attempted and will not attempt to obtain, and has not accepted and will not accept any direct or indirect benefit (finanical or otherwise) arising from a procurement contract or the award thereof;
- i. it has zero tolerance for sexual exploitation and abuse and has appropriate procedures in place to prevent and respond to sexual exploitation and abuse.

The Company understands that a false statement or failure to disclose any relevant information which may impact upon SLMC's decision to award a contract may result in the disqualification of the Company from the bidding exercise and/or the withdrawal of any proposal of a contract with SLMC. Furthermore, in case a contract has already been awarded, SLMC shall be entitled to rescind the contract with immediate effect, in addition to any other remedies which SLMC may have by contract or by law.
